

Eyecare Partners shares and options out of escrow

Directors of Eyecare Partners Limited have advised that in accordance with Australian Securities Exchange listing rule 3.10A 'Forthcoming release of restricted securities subject to volun-

tary escrow' that 19,647,912 new shares will be released from escrow on the 20 August 2008.

They have also advised that the vesting conditions attaching to 1.3 million options will be satisfied on the

9 August 2008 and the company will apply for quotation of those options.

The options were issued to the managing director, Ms Sam Andersen, and have an exercised price of \$0.20 and expire on the 30 September 2010.
